

**TOWNSHIP OF HAMPTON**

**ORDINANCE NO. 822**

**AN ORDINANCE AMENDING AND SUPPLEMENTING PARTS OF ORDINANCE NO. 70 – "AN ORDINANCE OF THE TOWNSHIP OF HAMPTON, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, PROVIDING THE REQUIREMENT FOR SERVICE CONNECTING SEWERS, THE CONNECTION CHARGES THEREFORE, ESTABLISHING SEWER RENTAL CHARGES AND PROVIDING FOR BILLING AND COLLECTING THEREOF FOR THE HAMPTON TOWNSHIP SEWER COLLECTION DISTRICT FOR ALL RESIDENTIAL AND NON-RESIDENTIAL USERS AND PROVIDING FINES AND PENALTIES FOR VIOLATIONS" AS AMENDED.**

**THE TOWNSHIP OF HAMPTON, ALLEGHENY COUNTY, PENNSYLVANIA, ORDAINS AS FOLLOWS:**

Article VI, Section 601 of Ordinance No. 70 of the Township of Hampton, as amended by Ordinances Nos. 325, 439, 464, 484, 491, 566, 631, 665, 715, 746 and 757, is amended as follows:

Section 601(c). All owners of residential and/or non-residential property that have available the use of the sewerage system of the Hampton Township Sewer District shall pay to the Township a Sanitary Sewer Capital Fee. Sections (1) and (3) of 601(c) set forth in Ordinance No. 757 shall remain in effect. Section 601(c)(2) shall be amended as follows:

- a. For 2019, the Sanitary Sewer Capital Fee shall be set at Ten Dollars and Fifty (\$10.50) Cents per month, or Twenty-One (\$21.00) Dollars per sanitary sewer billing cycle;
- b. For 2020, the Sanitary Sewer Capital Fee shall be set at Eighteen (\$18.00) Dollars per month, or Thirty-Six (\$36.00) Dollars per sanitary sewer billing cycle;
- c. For 2021, the Sanitary Sewer Capital Fee shall be set at Twenty-Five Dollars and Fifty (\$25.50) Cents per month, or Fifty-One (\$51.00) Dollars per sanitary sewer billing cycle;

- d. For 2022, the Sanitary Sewer Capital Fee shall be set at Thirty-Three (\$33.00) Dollars per month, or Sixty-Six (\$66.00) Dollars per billing cycle.

Article IX (repeated). If any section, subsection, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional such invalidity or unconstitutionality shall not affect the validity or constitutionality of the remaining portions of this ordinance and each section, subsection, sentence, clause and phrase hereof has been prepared, proposed, adopted, approved and ratified irrespective of the fact that any one or more other section, subsection, sentence, clause or phrase be declared invalid or unconstitutional;

Article X (repeated). All ordinances or parts of ordinances insofar as they are inconsistent with this ordinance are hereby repealed.


Article XI. The requirements of this ordinance shall become effective for any billing on or after the 2<sup>nd</sup> day of January 2019.


